IT IS, THEREFORE, ORDERED that the Christmas Valley
Domestic Water Supply District of Lake County, Oregon, be, and
hereby is, organized as a domestic water supply district under the
laws of the State of Oregon as set forth in Chapter 264 of the Oregon
Revised Statutes, and IT IS FURTHER ORDERED that the name of said
district shall be "Christmas Valley Domestic Water Supply District".

IT IS FURTHER ORDERED that the boundaries of said District should include the land described in the petition less the N½S½ of Section 9 of Township 27 South, Range 17 East of the Willamette Meridian, since said land is not platted and in immediate need of

domestic water, the revised boundaries of the District, therefore, being described as follows:

Township 27 South, Range 17 East of the Willamette Meridian Section 9: Stst Section 10: All Section 11: SWI Section 13: NW Section 14: N15 Section 15: NINI Section 16: N12N12 Section 17: W1, NE4, N1/SE4, SW1/SE4 Section 18: A11

at which time five (5) persons, the number of proposed board members named in the petition for formation, shall be elected to be the initial Board of Directors, pursuant to the provisions of ORS 198.825, no election for the formation of the District being necessary due to the fact that written requests for election were not filed by fifteen percent (15%) of the registered voters resident within the proposed district, pursuant to the provisions of ORS 198.810.

be given by publication in the Lake County Examiner, a newspaper of general circulation within the boundaries of the District, and published within Lake County, Oregon, in the issues of May 24, 1973 and May 31, 1973, which publications are at least fifteen (15) days prior and five (5) days prior respectively to the election called for herein.

IT IS FURTHER ORDERED that the voting place for such election shall be at the Christmas Valley Fire Hall, Christmas Valley, Oregon, which place is within the boundaries of the District, and that the polls shall remain open from 8:00 A.M., Pacific Daylight Time, until 8:00 P.M., Pacific Daylight Time.

IT IS FURTHER ORDERED that Zane Gray, County Clerk, shall designate three (3) election clerks, who shall also constitute the counting board, the chairman of which shall report the results of the

election to the Lake County Clerk.
